RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC, THROUGH THE HONORABLE ACTING MUNICIPAL MAYOR RAMON BENITO M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH CENTRAL LUZON CENTER FOR HEALTH DEVELOPMENT FOR THE RELEASE OF FUNDS COVERING THE GRANT OF THE COVID-19 HEALTH EMERGENCY ALLOWANCE TO QUALIFIED PUBLIC HEALTH WORKERS IN THE MUNICIPAL HEALTH OFFICE OF MONCADA FOR THE PERIOD JULY 2022 TO NOVEMBER 2022, INCLUSIVE MONTHS, AND JANUARY 2023 AND APRIL 2023

WHEREAS, the DOH Central Luzon Center for Health Development (DOH-CLCHD) recognizes the invaluable role of Public Health Workers during the time of national health emergency due to the recent COVID-19 pandemic;

WHEREAS, pursuant to RA 11712, otherwise known as Public Health Emergency Benefits and Allowances for Health Care Workers Act and its IRR, qualified public health workers shall receive Health Emergency Allowance (HEA), particularly the medical frontliners directly catering to COVID-19 patients, which shall be retroactive from July 1, 2021;

WHEREAS, in view of the foregoing premises, the proposed Memorandum of Agreement was submitted to this August Body, requesting that authority be granted the Acting Local Chief Executive to enter into said agreement for and on

behalf of the Municipal Government of Moncada for the grant of HEA for the period July 2022 to November 2022, inclusive months, and January 2023 and April 2023;

WHEREAS, after a thorough perusal of the MOA, the SB finds the same to be of merit;

NOW, THEREFORE, on motion by Coun. Thelmaflor A. Espejo, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations, hereby authorizes the Municipal Government of Moncada, Tarlac, through the Honorable Acting Municipal Mayor Ramon Benito M. Aquino, to enter into a memorandum of agreement with the Department of Health Central Luzon Center for Health Development for the release of funds covering the grant of the COVID-19 Health Emergency Allowance to qualified public health workers in the Municipal Health Office of Moncada for the period July 2022 to November 2022, inclusive months, and January 2023 and April 2023;

RESOLVED, FURTHER, that this Resolution be furnished the Municipal Mayor and DOH-CLCHD for their information and appropriate action;
