Greetings from the Municipal Government of Moncada!

I am writing to formally express our humble intent to request the installation and maintenance of various road safety devices, equipment, and signages within the Municipality of Moncada, Tarlac.

The Municipal Government of Moncada has observed an alarming increase in the number of road accidents, particularly involving motorcycles, which have been identified as the leading cause of vehicular accidents in our municipality. This year's data indicates a higher number of incidents compared to last year, underscoring the urgent need for enhanced road safety measures.

In light of this situation, we earnestly request the Department of Public Works and Highways First District Engineering Office of Tarlac to assist us in addressing these safety concerns by installing and maintaining the following road safety devices and signages:
