**RESOLUTION ADOPTING THE USAGE OF THE WAREHOUSE OPERATIONS
MANUAL AS THE TECHNICAL GUIDELINES IN THE IMPLEMENTATION OF THE
HARMONIZED SUPPLY CHAIN MANAGEMENT IN THE MUNICIPALITY OF
MONCADA, TARLAC**

WHEREAS, the Universal Health Care Act provides for a framework that fosters a whole-of-system, whole-of-government and whole-of-society approach in the development, implementation, monitoring, and evaluation of health policies, programs and plans;

WHEREAS, the Department of Health (DOH) through the issuance of Memorandum 2021-0444 enjoins all concerned stakeholders to adopt and use the Warehouse Operations Manual to standardize warehouse operations;

WHEREAS, pursuant to DOH Administrative Order 2020-0037, the approved technical guidelines/manual on the implementation of harmonized supply chain management system will provide for the following provisions, to wit: warehousing, distribution centers and consumption monitoring, inventory management, transportation strategies and proper storage and disposal of medicines and health commodities;

WHEREAS, the adoption of the Warehouse Operations Manual will ensure the monitoring, control and optimization of warehouse and transportation system relative to the delivery of health care goods and health services;


