**RESOLUTION APPROVING ON REVIEW BARANGAY CALAPAN ROAD CLEARING

WHEREAS, pursuant to the provisions of the Local Government Code of the Philippines, the Sangguniang Bayan of Moncada, Tarlac, has the authority to review and approve ordinances enacted by the Sangguniang Barangays within its jurisdiction;

WHEREAS, Barangay Calapan of Moncada, Tarlac, has enacted a Road Clearing Ordinance aimed at ensuring the accessibility and safety of public roads within its territorial jurisdiction;

WHEREAS, the Sangguniang Bayan of Moncada, Tarlac, has conducted a thorough review of the said Road Clearing Ordinance;

WHEREAS, upon careful examination and evaluation, it has been determined that the Road Clearing Ordinance enacted by Barangay Calapan is consistent with the mandates of the Local Government Code and falls within the conferred powers of the Sangguniang Barangay to enact;

WHEREAS, it is imperative to recognize the autonomy of Barangays in promulgating measures that contribute to the welfare and development of their respective communities, including initiatives to ensure efficient traffic flow and road safety;
