RESOLUTION GRANTING AN INVESTMENT TAX HOLIDAY TO ENVIROKONSULT EQUIPMENT AND SERVICES, INC. FOR THEIR SEPTAGE MANAGEMENT PROGRAM UNDER A PUBLIC-PRIVATE PARTNERSHIP (PPP) IN THE MUNICIPALITY OF MONCADA, TARLAC

WHEREAS, the Municipality of Moncada, Tarlac, and Envirokonsult Equipment and Services, Inc. entered into a Joint Venture Agreement under a Public-Private Partnership (PPP) for the implementation of a Septage Management Program in the municipality;

WHEREAS, the said project is in line with the objectives of the Municipality to comply with environmental national and local laws while promoting the health and well-being of its constituents;

WHEREAS, pursuant to Section 3.9 of the Public-Private Partnership Code of Moncada (Municipal Ordinance No. 06, Series of 2019), PPP projects may be supported by appropriate incentives to create an enabling environment for private sector investment;

WHEREAS, Envirokonsult Equipment and Services, Inc., through its President and CEO, Dr. Anthony V. Gedang, has formally requested an investment tax holiday to alleviate initial operational challenges and ensure the viability and sustainability of the Septage Management Project;

WHEREAS, the Sangguniang Bayan of Moncada recognizes the importance of this project in addressing environmental concerns and enhancing public health, thereby deeming it appropriate to grant the requested tax incentive;

NOW, THEREFORE, on motion by Coun. Celeste A. Ayson and duly seconded by Coun. Thelmaflor A. Espejo;

RESOLVED, that the Sangguniang Bayan of Moncada, Tarlac, hereby grants an investment tax holiday to Envirokonsult Equipment and Services, Inc. for their Septage Management Project under the following terms:

First Year of Operations: Waived Business Tax
Second Year of Operations: To settle 25% of Computed Business Tax
Third Year of Operations: To settle 50% of Computed Business Tax
Fourth Year of Operations: To settle 75% of Computed Business Tax
Fifth Year of Operations and thereafter: 100% of Computed Business Tax shall be imposed.

RESOLVED FURTHER, that copies of this resolution be furnished to the Honorable Mayor Estelita M. Aquino and the CEO of Envirokonsult Equipment and Services, Inc. for their information and appropriate action;
