**RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A DEED OF DONATION WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) FOR THE ACCEPTANCE AND RECEIPT OF PATIENT TRANSPORT VEHICLE (PTV) IN FAVOR OF THE LGU OF MONCADA**

**WHEREAS**, the Municipal Government of Moncada, Tarlac, has recognized the need to enhance its emergency medical services to ensure the well-being and timely transport of patients in the community;

**WHEREAS**, the Philippine Charity Sweepstakes Office (PCSO) is a government agency mandated to generate funds for health programs and charitable endeavors throughout the country;

**WHEREAS**, the PCSO has informed the Municipal Government of Moncada about its eligibility to be granted a Patient Transport Vehicle (PTV) to support and improve the emergency medical services in the municipality. This initiative is based on the letter of intent submitted by the Honorable Congressman Jaime D. Cojuangco to the PCSO who requested ambulance units for various barangays of this municipality;
