WHEREAS, the Sangguniang Barangay of Banaoang West has modified its seal through the enactment of Barangay Ordinance No. 01, Series of 2024 titled "An ordinance Creating the Official Logo/Seal of the Local Government of Banaoang West, Moncada, Tarlac, Prescribing the Use and Imposing Penalty for Unofficial/Unauthorized Use Thereof;"

WHEREAS, Section 447 (1)(i) of the Local Government Code empowers the Sangguniang Bayan to review barangay ordinances and to confirm or disapprove the same within thirty (30) days from their submission;
