**RESOLUTION CONFIRMING ON REVIEW SAN JULIAN BARANGAY ORDINANCE NO. 08, SERIES OF 2024 TITLED "AN ORDINANCE DESIGNATING LOADING AND UNLOADING ZONES FOR PUBLIC UTILITY BUSES AND OTHER PUBLIC UTILITY VEHICLES TRAVERSING THE MC-ARTHUR HIGHWAY ALONG BARANGAY SAN JULIAN, MONCADA, TARLAC, PENALIZING VIOLATORS THEREOF, AND FOR OTHER PURPOSES" AS VALID AND WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT**

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," grants local government units the power to exercise autonomy and enact ordinances that promote the general welfare of their constituents;

**WHEREAS**, the Sangguniang Barangay of San Julian enacted Barangay Ordinance No. 08, Series of 2024, entitled "An Ordinance Designating Loading and Unloading Zones for Public Utility Buses and Other Public Utility Vehicles Traversing the McArthur Highway Along Barangay San Julian, Moncada, Tarlac, Penalizing Violators Thereof, and for Other Purposes," with the aim of promoting road safety, traffic order, and convenience in public transportation within the jurisdiction of Barangay San Julian;

**WHEREAS**, the Sangguniang Bayan of Moncada has reviewed San Julian Barangay Ordinance No. 08, Series of 2024, and has determined that the ordinance is within the powers conferred upon the Sangguniang Barangay by the Local Government Code and related laws, rules and regulations;

**RESOLVED, FURTHER**, that copies of this resolution be furnished to the Sangguniang Barangay, through its Punong Barangay, for their information and guidance.


