RESOLUTION NO. 2024-080

RESOLUTION AUTHORIZING THE HONORABLE MAYOR ESTELITA M. AQUINO TO ENTER INTO A MEMORANDUM OF UNDERTAKING WITH BOUNTY FRESH FOOD INC. FOR THE CONSTRUCTION OF A POULTRY FARM AND ASSOCIATED INFRASTRUCTURE IN BARANGAY STA. MONICA, MONCADA, TARLAC

WHEREAS, Bounty Fresh Food Inc. (BFFI), duly represented by Mr. Rogelio G. Avedoza, IBG Operations Manager, intends to develop a poultry farm (hereafter known as Macadamia Farm) in Barangay Sta. Monica, Moncada, Tarlac, from December 2024 to November 2026;

WHEREAS, the construction activities for the Macadamia Farm require the use of the Farm to Market Road (FMR) in Barangay Sta. Monica, which may incur damage from heavy equipment, dump trucks, and construction vehicles;

WHEREAS, BFFI has committed to restore and repair the FMR road, specifically a 400x5-meter concrete section and a 180x5-meter section without concrete, following the completion of construction, ensuring it meets the standards set by the Local Government Unit (LGU) of Moncada;

WHEREAS, this undertaking aims to preserve and protect the integrity of roads, particularly the FMR, to ensure that the livelihood and safety of farmers, road users, and everyone engaged in agricultural activities are safeguarded;

WHEREAS, the Sangguniang Bayan of Moncada finds it in the best interest of the municipality to authorize the Local Chief Executive to formalize this

agreement with BFFI to ensure that any potential impacts on public infrastructure are adequately addressed;

NOW, THEREFORE, on motion of Coun. Celeste A. Ayson, duly seconded by Coun. Constante Nestor A. Favis;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Agriculture and the Committee on Infrastructure, hereby authorizes the Honorable Mayor Estelita M. Aquino to enter into a Memorandum of Undertaking with Bounty Fresh Food Inc. (BFFI), represented by IBG Operations Manager Mr. Rogelio G. Avedoza, to establish the terms and commitments for the construction of a Poultry Farm in Barangay Sta. Monica, Moncada, Tarlac, including BFFI's responsibility to restore, repair and/or improve any affected sections of the Farm to Market Road (FMR) upon project completion;

RESOLVED, FURTHER, that copies of this Resolution be furnished to Mayor Estelita M. Aquino and the Mr. Avedoza of BFFI for their information and appropriate action;
