RESOLUTION CONFIRMING ON REVIEW MALUAC BARANGAY ORDINANCE NO. 01, SERIES OF 2024 RELATIVE TO ITS NEWLY MODIFIED BARANGAY SEAL/LOGO, AS VALID, AND WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT

WHEREAS, the Sangguniang Barangay of Maluac has modified its seal through the enactment of Barangay Ordinance No. 01, Series of 2024 titled "An ordinance Creating the Official Logo/Seal of the Local Government of Maluac, Moncada, Tarlac, Prescribing the Use and Imposing Penalty for Unofficial/Unauthorized Use Thereof;"

WHEREAS, Section 447 (1)(i) of the Local Government Code empowers the Sangguniang Bayan to review barangay ordinances and to confirm or disapprove the same within thirty (30) days from their submission;

WHEREAS, the Sangguniang Bayan of Moncada, Tarlac has conducted a thorough review of the proposed barangay ordinance pertaining to the modification of barangay seal, and finds the same to be well within the scope of the authority of the Sangguniang Barangay to enact;

WHEREAS, the modification in the barangay seal is deemed reasonable, reflective of the identity and aspirations of Barangay Maluac, and in compliance with existing laws and regulations;
