RESOLUTION NO. 2024-089

RESOLUTION ADOPTING AND LOCALIZING REPUBLIC ACT NO. 11862, OTHERWISE KNOWN AS THE "EXPANDED ANTI-TRAFFICKING IN PERSONS ACT OF 2022," IN THE MUNICIPALITY OF MONCADA, TARLAC

WHEREAS, Republic Act No. 11862 strengthens the Philippines' commitment to combating human trafficking, particularly through provisions addressing online platforms, law enforcement responsibilities, and protection of vulnerable individuals;

WHEREAS, the Municipality of Moncada is committed to protecting its residents, particularly women, children, and other vulnerable groups, from exploitation and trafficking in all forms;

WHEREAS, there is a need to align local policies and programs with the mandates of RA 11862 to ensure effective implementation and safeguard Moncada's residents;

NOW, THEREFORE, on motion by Coun. Alberto C. Marzan, Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Social Welfare, Women and Children and Family, hereby adopts and localizes Republic Act No. 11862, otherwise known as the "Expanded Anti-Trafficking in Persons Act of 2022," in the Municipality of Moncada, Tarlac, to wit:

1. To adopt Republic Act No. 11862 in its entirety, and localize its provisions to address the specific needs and conditions of the Municipality of Moncada;
2. To mandate the creation of a Local Anti-Trafficking Task Force, headed by the Mayor or her authorized representative, to coordinate and monitor all anti-trafficking initiatives within the municipality;
3. To integrate anti-trafficking programs and activities into the Annual Investment Program and allocate appropriate funding for these programs;
4. To direct all barangays to support the implementation of anti-trafficking measures by conducting awareness campaigns, reporting suspected trafficking activities, and assisting in the protection of victims;
5. To ensure training and capacity building for law enforcement agencies and local officials to effectively implement the provisions of the Act;

RESOLVED, FURTHER, that copies of this Resolution be furnished the Municipal Mayor, MSWDO, the Local Committee on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC) and all other concerned parties for their information and appropriate action;
