WHEREAS, the Philippine Red Cross, in its mandate to provide humanitarian assistance and recovery programs, has identified the Municipality of Moncada, Tarlac, as a priority area for its livelihood program;

WHEREAS, the proposed livelihood program aims to provide Household Livelihood Assistance (Conditional Cash Grant) to the most vulnerable population affected by Tropical Depression Butchoy and SuperTyphoon Carina to help them recover and rebuild their means of livelihood;

WHEREAS, the Philippine Red Cross seeks to enter into a Memorandum of Agreement (MOA) with the Municipality of Moncada to ensure the proper implementation, coordination, and monitoring of the said livelihood program;
