RESOLUTION INTERPOSING NO OBJECTION TO THE RESUMPTION OF TRADITIONAL COCKFIGHTING OR "SABONG" WITH CASHLESS AND TECHNOLOGY-BASED BETTING PLATFORMS IN THE MUNICIPALITY OF MONCADA, SUBJECT TO EXISTING STATUTORY AND REGULATORY REQUIREMENTS

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases approved through Resolution No. 154, Series of 2021 and Resolution No. 164-D, Series of 2022, the recommendations of the Technical Working Group to allow the operation of cockpits and traditional cockfighting in areas under Alert Level 2 and below;

WHEREAS, the approval came with certain conditions that the operation of Sabong shall be conducted using cashless and technology-based betting platforms inside cockpit arenas and that all workers, employees and participants of these cockpits shall be fully-vaccinated against COVID-19;

WHEREAS, the Municipality of Moncada, now under Alert Level 1, shall allow 100% capacity of licensed cockpit venues with strict enforcement of minimum public health standards and full compliance with the abovementioned conditions and other statutory and regulatory requirements provided by existing laws and ordinances;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Games and Amusement, hereby interposes no objection to the resumption of traditional cockfighting or "Sabong" with cashless and technology-based betting platforms in the Municipality of Moncada, subject to existing statutory and regulatory requirements;

RESOLVED, FURTHER, that only licensed and duly permitted cockpit operators shall be allowed to resume their operations. Failure thereof to comply with the statutory and regulatory requirements shall be dealt with accordingly pursuant to existing laws and ordinances;

RESOLVED, FINALLY, that copies of this Resolution be furnished all concerned offices and agencies for their information and appropriate action;
