**RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC FOR CY 2023 IN THE TOTAL AMOUNT OF TWELVE MILLION TWO HUNDRED TWENTY ONE THOUSAND TWO HUNDRED THIRTY TWO PESOS AND 71/100 (P 12,221,232.71) FOR VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES OF THE MUNICIPAL GOVERNMENT**

Chairman, Committee on Finance, Ways and Means and Appropriations**

**WHEREAS**, the Local Government Unit of Moncada, Tarlac recognizes the importance of investing in projects that will contribute to the growth and development of the municipality and improve the quality of life of its constituents;

**WHEREAS**, the LGU Moncada, Tarlac has identified the need to create new plantilla positions, construct a new Business Permits and Licensing Office, provide funding for other machineries and equipment (supply, delivery and installation of outdoor playground equipment), funding for the concreting of children's playground in the public plaza, supply and installation of grid-connected solar photovoltaic power system at the new SB-ABC-SK building, and various expenses for the Municipal Environment and Natural Resources Office (MENRO);

**WHEREAS**, the total cost of the said PPAs is PHP 12,221,232.71, which is not included in the Annual Investment Program (AIP) for the current fiscal year;

**WHEREAS**, Section 336 of the Local Government Code of 1991 allows the Local Chief Executive, with the concurrence of the Sanggunian concerned, to authorize the utilization of surplus and any savings from other appropriations for

the current year to cover any deficiency in any item of the regular budget of the current year;

**NOW, THEREFORE,** on motion by Coun. Thelmaflor A. Espejo, duly seconded;

**RESOLVED,** that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations, hereby approves the Supplemental Annual Investment Program of the Municipal Government of Moncada, Tarlac in the total amount of twelve million two hundred twenty one thousand two hundred thirty two pesos and 71/100 (P 12,221,232.71) for the following PPAs, to wit:
