RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT AND MUTUAL CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT WITH G-XCHANGE, INC. FOR THE PROVISION OF G-CASH DIGITAL PAYMENT CHANNEL IN THE MUNICIPAL GOVERNMENT OF MONCADA

WHEREAS, the matter under consideration by this August Body is a proposed Memorandum of Agreement between the LGU of Moncada and G-Xchange Inc., a wholly-owned subsidiary of Globe Fintech Innovations, Inc. which is engaged in digital payment system under the brand name “G-Cash;”

WHEREAS, said agreement enables the LGU of Moncada to accept and collect business tax and real property tax payments through G-Cash channel which is widely available among the citizens;

WHEREAS, Section 2 of Republic Act No. 8792 or the “Electronic Commerce Act of 2000” (E-Commerce Act), as reiterated in Executive Order No. 170 (s.2022) issued by former President Rodrigo R. Duterte, underscores the need to create an information friendly environment which ensures the availability, diversity and affordability of information and communications technology. It further affirms that the State recognizes the primary responsibility of the private sector in contributing investments and services in telecommunications and information technology;

WHEREAS, the Memorandum of Agreement shall be made in accordance with the Joint Administrative Order No. 02, Series of 2006 of the Department of

Trade and Industry and Department of Finance entitled "Guidelines Implementing R.A. 8792 on Electronic Payment and Collection System (EPCS) in Government";

WHEREAS, after a careful review and study of the terms and conditions provided in the MOA, the SB finds the electronic payment and collection system beneficial and advantageous to the Municipality of Moncada;

NOW, THEREFORE, on motion by Coun. George Michael P. Aguilar duly seconded by Coun. Thelmaflor A. Espejo;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations and Committee on Trade and Industry, hereby authorizes the Municipal Government of Moncada, through the Honorable Mayor Estelita M. Aquino, to enter into a memorandum of agreement and mutual confidentiality and non-disclosure agreement with G-Xchange, Inc. for the provision of G-Cash digital payment channel in the Municipal Government of Moncada;
