**RESOLUTION REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT, THROUGH THE HONORABLE SECRETARY WENDEL E. AVISADO, FOR THE ALLOCATION OF ADDITIONAL FUND AMOUNTING TO TWENTY-FIVE MILLION PESOS (P 25,000,000.00) FOR THE PROPOSED CONSTRUCTION OF SLOPE PROTECTION OF BAKET-BAKET CREEK (PHASE II) ALONG BARANGAYS CAMANGAAN EAST – BURGOS – TOLEGA SUR OF THIS MUNICIPALITY**

**WHEREAS**, the Municipality of Moncada is situated in a flood-catchment area, hence, the LGU has incorporated in its Annual Investment Program the proposed construction of slope protection of Baket-Baket Creek snaking through Barangays Camangaan East – Burgos – Tolega Sur of this municipality;

**WHEREAS**, due to financial constraints, the Municipal Government of Moncada, through Sangguniang Bayan Resolution No. 53, Series of 2020, has submitted its request for funding allocation amounting to fifty million pesos (P50,000,000.00) to the Department of Budget Management;

**WHEREAS**, subsequent analysis of the technical requirement therefor shows that said amount would not be sufficient to complete the said project, hence, the need for an additional twenty-five million pesos (P25,000,000.00) for the Phase II thereof;
