RESOLUTION REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT, THROUGH THE HONORABLE SECRETARY WENDEL E. AVISADO, FOR THE ALLOCATION OF FUNDS IN THE AMOUNT OF TEN MILLION PESOS (PHP 10,000,000.00) FOR THE PROPOSED CONCRETING OF STA MONICA FARM TO MARKET ROAD AT BARANGAY STA MONICA OF THIS MUNICIPALITY

WHEREAS, Local Budget Circular No. 131 issued by the Department of Budget and Management (DBM) on January 8, 2021 grants financial assistance to qualified Local Government Units (LGUs) for their priority development programs;
