RESOLUTION CERTIFYING AND CONFIRMING THE INCOME CLASSIFICATION OF MONCADA AS A FIRST-CLASS MUNICIPALITY PURSUANT TO DEPARTMENT OF FINANCE ORDER NO. 23-08 DATED JULY 29, 2008 OTHERWISE KNOWN AS AN ORDER PRESCRIBING THE NEW INCOME BRACKETS FOR THE RE-CLASSIFICATION OF PROVINCES, CITIES AND MUNICIPALITIES

WHEREAS, the income classification of Provinces, Cities and Municipalities serves, among other purposes, as basis for the determination of the financial capability of Local Government Units (LGUs) to provide in full or in part the funding requirements of developmental projects and other priority needs in their locality;

WHEREAS, in the preparation of project studies and proposals, the income class of LGUs is used as a factor in the allocation of national or other financial grants as well as the determination of the maximum amount of expendable for salaries and wages, including salary scales and rates of allowances, per diems, and other emoluments that LGU officials and personnel may be entitled to;

WHEREAS, considering the marked increase in the Internal Revenue Allotment (IRA) share and corresponding improvement in the tax collection performance of Moncada, the same was reclassified as a First-Class Municipality by the Department of Finance pursuant to Department Order No. 23-08 dated July 29, 2008;


NOW, THEREFORE, on motion by Coun. Cleofe D. Favis, duly seconded:
