**RESOLUTION EARNESTLY REQUESTING THE HONORABLE SENATOR RISA HONTIVEROS FOR FUNDING ALLOCATION AMOUNTING TO TEN MILLION PESOS (P 10,000,000.00) FOR THE PROPOSED COMPLETE REHABILITATION OF THE DILAPIDATED ROAD CONNECTING BARANGAY BURGOS TO BARANGAY TOLEGA SUR OF THIS MUNICIPALITY**

**WHEREAS**, the Municipality of Moncada, through its Local Development Council, has identified various infrastructure projects that will contribute to the socio-economic development of the town;

**WHEREAS**, in the furtherance of the above development agenda, the LGU has incorporated in its Local Development Investment Program and Annual Investment Program the proposed complete rehabilitation of the dilapidated road connecting Barangay Burgos to Barangay Tolega Sur of this municipality amounting to ten million pesos (P10,000,000.00) to provide our people a safe access route going to and from the central business district of Moncada and adjacent barangays;

**WHEREAS**, taking into account the considerable budgetary requirement for this project, the meager funds of this Local Government Unit hinder the immediate funding of the above stated priority project, thus, this humble request for funding allocation from your good office;
