**RESOLUTION EARNESTLY REQUESTING THE MUNICIPAL ASSESSOR'S OFFICE AND BARANGAYS WITH JURISDICTION OVER THE PHILIPPINE NATIONAL RAILWAY (PNR) SITE TO CONDUCT A SURVEY AND INVENTORY OF HOUSEHOLDS AND STRUCTURES ERECTED THEREAT**

**WHEREAS**, the Sangguniang Bayan Committee on Rules, Legal Matters, Justice and Good Governance jointly with the Committee on Finance, Ways and Means and Appropriations and Committee on Agriculture and Land Utilization convened a meeting last February 18, 2021, acting on the issues involving properties of public domain appropriated by private individuals;

**WHEREAS**, the foregoing committees have recommended the survey and inventory of houses and building structures along the entire stretch of Philippine National Railway (PNR) traversing the municipality;

**WHEREAS**, this August Body therefore requests the assistance of the Municipal Assessor and Punong Barangays of Poblacion 1, Rizal, Mabini, Tubectubang, Camposanto 1 Norte, Poblacion 2, Camangaan East, San Julian and Sta Lucia East with jurisdiction over the PNR site to conduct the survey and enlistment of structures for records and reference purposes;
