RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA) REGIONAL OFFICE III FOR THE IMPLEMENTATION OF BALAY SILANGAN PROGRAM IN THE MUNICIPALITY OF MONCADA

WHEREAS, presented for consideration by this August Body is a proposed Memorandum of Agreement between the Philippine Drug Enforcement Agency (PDEA) Regional Office III and the Municipal Government of Moncada for the implementation of "Balay Silangan" program in the municipality;

WHEREAS, to effectively synchronize all efforts in the government's anti-illegal drug campaign towards the attainment of a drug-free country, there is a need for cooperation and close coordination between and among government agencies or offices;

WHEREAS, under the MOA, both parties shall ensure effective and efficient implementation of "Balay Silangan Program" which involves support and funding from the Local Government Unit such as infrastructure, manpower and other needs deemed necessary for the program;
