RESOLUTION NO. 27 – 2018

“A RESOLUTION AFFIRMING EXECUTIVE ORDER NO. 4, SERIES OF 2018, AN ORDER MANDATING THE UPDATE AND/OR REVISION OF RATES OF COLLECTION OF TAXES, FEES, CHARGES AND OTHER IMPOSITIONS”

WHEREAS, Rule XXX, Article 218 of the Rules and Regulations Implementing the Local Government Code of 1991 states that, “Power to Create Sources of Revenue – consistent with the basic policy of local autonomy, each LGU shall exercise its power to create its own sources of revenue and to levy taxes, fees, or charges, subject to the provisions of this Rule. Such taxes, fees, or charges shall accrue exclusively to the LGU.”;

WHEREAS, Article 281 of the said Rule also states that, “Authority to Adjust Rates of Taxes. – LGUs shall be authorized to adjust the tax rates prescribed in this Rule not oftener than once every five (5) years, but in no case shall such adjustments exceed ten percent (10%) of the rates fixed in this Rule.”;

WHEREAS, for several years now, the local government unit of Moncada has not updated and/or revised its rates of collection of taxes, fees, charges and other impositions leaving behind the municipality with the old collectible rates detrimental to its financially viable operation;

WHEREAS, it is now urgent and imperative to update rates of collections to conform with the needs and call of the time as everything had risen in terms of cost and for the local government unit to be able to deliver the very basic services needed and aspired for by its constituents.

WHEREAS, a careful review and study of the Executive Order, the same has been found to be in order for ratification;

NOW THEREFORE, premises considered and on motion by COUN. EDWARD V. TOLENTINO, duly seconded in session assembled;

RESOLVED, AS IT IS HEREBY RESOLVED, to Affirm Executive Order No. 4, Series of 2018, "An Order Mandating the Update and/or Revision of Rates of Collection of Taxes, Fees, Charges and Other Impositions", herein stipulated the updated taxes, fees and charges, to wit:


