RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF TARLAC, THROUGH THE HONORABLE GOVERNOR SUSAN A. YAP, FOR THE PURCHASE OF COVID-19 VACCINES

WHEREAS, the Honorable Mayor Estelita M. Aquino is endorsing to this August Body the proposed Memorandum of Agreement (MOA) with the Provincial Government of Tarlac for the purchase of COVID-19 vaccines aimed at augmenting supplies for the National Immunization Program of the government;

WHEREAS, foregoing MOA lays down the guidelines and terms and conditions of the immunization program to be jointly undertaken by the municipal and provincial government respectively, in accordance with the mandate of Republic Act 11525 otherwise known as the "COVID-19 Vaccination Program Act of 2021"

WHEREAS, after an in-depth review of the terms and conditions provided in the proposed agreement, the SB finds the same to be in order;

NOW, THEREFORE, on motion by Coun. Cleofé D. Favis, duly seconded:

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations, hereby authorizes the Municipal Government of Moncada, through the Honorable Mayor Estelita M. Aquino to enter into a Memorandum of Agreement with the Provincial
