RESOLUTION RECLASSIFYING A PARCEL OF LAND LOCATED AT BARANGAY BURGOS OWNED BY THE MUNICIPAL GOVERNMENT OF MONCADA, COVERED UNDER TRANSFER CERTIFICATE OF TITLE NO. 373862, FROM AGRICULTURAL TO COMMERCIAL

WHEREAS, Section 447(a) (2) (vii) of Republic Act 7160 otherwise known as the Local Government Code of 1991 authorizes the Sangguniang Bayan to reclassify lands within its territorial jurisdiction;

WHEREAS, section 20 of the same code provides that the Sangguniang Bayan, through an ordinance, may reclassify lands and provide for the manner of their utilization or disposition where the land shall have substantially greater economic value for residential, commercial, or industrial purposes;

WHEREAS, the land subject for reclassification is owned by the Municipal Government of Moncada, Tarlac with an aggregate land area of nineteen thousand square meters (19,000 sqm), more or less, covered under Transfer Certificate of Title No. 373862;
