RESOLUTION APPROVING THE REALIGNMENT OF THE TWENTY PERCENT (20%) DEVELOPMENT FUND OF THE MUNICIPALITY OF MONCADA FOR CALENDAR YEAR 2020 AMOUNTING TO THIRTY-ONE MILLION NINE HUNDRED FORTY-NINE THOUSAND EIGHT HUNDRED THIRTY-EIGHT PESOS AND 40/100 (PHP 31,949,838.40)

WHEREAS, for consideration by this Sanggunian is the proposed realignment of programs, projects and activities (PPAs) contained in the 20% Development Fund of the municipality for CY 2020;
