RESOLUTION REQUESTING THE HONORABLE SENATOR CHRISTOPHER LAWRENCE "BONG" TESORO GO FOR THE ALLOCATION OF FUNDS IN THE AMOUNT OF FORTY MILLION FIVE HUNDRED NINETY THOUSAND PESOS (PHP 40,590,000.00) FOR THE PROPOSED CONCRETING OF A FARM TO MARKET ROAD AT BARANGAY BANAANG WEST, THIS MUNICIPALITY

WHEREAS, the Municipality of Moncada, through its Local Development Council, has identified various infrastructure projects that will contribute to the socio-economic development of the town;

WHEREAS, considering that Moncada prides itself of a good number of achievements in agricultural productivity, the LGU remains committed to improving the town's infrastructure network base, particularly farm to market roads;

WHEREAS, in support of the foregoing projects, the LGU has incorporated in its 2020 Annual Investment Program the proposed concreting of a farm-to-market road at Brgy. Banaang West amounting to Forty Million Five Hundred Ninety Thousand Pesos (Php 40,590,000.00);

WHEREAS, much to the desire of the local government to implement the said project, it would not be feasible as yet due to financial constraints to cover the expenses therefor;




