RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR THE REHABILITATION AND IMPROVEMENT OF VARIOUS OFFICES OF THE MUNICIPAL BUILDING OF MONCADA, TARLAC AMOUNTING TO THIRTEEN MILLION NINE HUNDRED NINE THOUSAND PESOS (PHP 13,909,000.00)

WHEREAS, presented to the Sangguniang Bayan for legislative consideration and review is the proposed Annual Investment Program ("AIP") for rehabilitation and improvement of various offices of the municipal building;

WHEREAS, this AIP is a tool by which a Local Government Unit provides budgetary support to its Local Development Plan (LDP) and Development Investment Program (LDIP) and translates the locality's development thrusts into tangible programs and projects;

WHEREAS, the adoption of the same AIP is essential as it serves as the basis for the funding of several programs and projects of the Municipality as incorporated in the Fiscal Year 2018 Annual Budget;

NOW, THEREFORE, on motion by COUN. EDWARD V. TOLENTINO, Chairperson, Committee on Finance, Ways & Means and Appropriations and unanimously seconded;

RESOLVED, TO APPROVE, AS IT IS HEREBY APPROVED, THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR THE REHABILITATION AND IMPROVEMENT OF VARIOUS OFFICES OF THE MUNICIPAL BUILDING OF MONCADA, TARLAC AMOUNTING TO THIRTEEN MILLION NINE HUNDRED NINE THOUSAND PESOS (Php 13,909,000.00);




