RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM FOR CY 2021 OF THE MUNICIPAL GOVERNMENT OF MONCADA FOR THE PROPOSED EXPANSION OF EXISTING PUBLIC MARKET, CONSTRUCTION OF SLAUGHTERHOUSE AT BRGY. BURGOS AND CONSTRUCTION OF MUNICIPAL CEMETERY III AT BRGY. CAMPOSANTO I NORTE

WHEREAS, for consideration by this Sanggunian is the proposed Supplemental Investment Program (SIP) of the Municipality of Moncada for CY 2021 containing therein projects and corresponding expenditure outlay of the Municipal Government for the current Fiscal Year;

WHEREAS, the submitted SIP contains the proposed Expansion of Existing Public Market, Construction of Slaughterhouse at Brgy. Burgos and Construction of Municipal Cemetery III at Brgy. Camposanto I Norte;

WHEREAS, the Municipal Government of Moncada has proposed an amount of one hundred five million pesos (P 105,000,000.00) for the said projects through a loan agreement with the LandBank of the Philippines;
