RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE PHILIPPINE RED CROSS FOR THE IMPLEMENTATION OF DISASTER REDUCTION, RESPONSE AND RECOVERY INITIATIVES

WHEREAS, the Honorable Mayor Estelita M. Aquino is endorsing to this August Body the proposed Memorandum of Understanding (MOU) between the LGU and Philippine Red Cross for the implementation of disaster reduction, response and recovery initiatives in times of calamities;

WHEREAS, said MOU upholds the State policy to adopt a disaster reduction and management approach that is holistic, comprehensive, integrated and proactive in reducing the socio-economic and environmental impacts of disasters, including climate change, and promote the involvement and participation of all sectors and stakeholders concerned at all levels;

WHEREAS, the LGU recognizes Philippine Red Cross – Tarlac Chapter, as a support humanitarian organization, that in the event of catastrophic disaster, or any related emergencies that may occur, it has the ability to provide voluntary disaster management services, welfare service, health service and blood service and other health-related services to the victims during and after the occurrence thereof;
