**RESOLUTION DECLARING THE ENTIRE MUNICIPALITY OF MONCADA UNDER A STATE OF CALAMITY DUE TO THE ONSLAUGHT OF HEAVY FLOODS BROUGHT ABOUT BY RECENT TROPICAL DEPRESSIONS AND SOUTHWEST MONSOON**

WHEREAS, the continuous downpour of heavy rains due to southwest monsoon and the recent Tropical Depressions 'Inday' and 'Josie' had inundated most of the barangays of this Municipality;

WHEREAS, flood waters, as a result, have destroyed agricultural crops and as per partial report from the Municipal Social Welfare and Development Office (MSWDO) at least five thousand five hundred seventy (5,570) families in the Municipality are affected forcing them to flee from their homes and temporarily stay in evacuation centers;

WHEREAS, the aftermath of this natural calamity renders it imperative for the line agencies of the government to immediately suspend classes at all levels within the municipality, considering that many roads are non-passable to all types of vehicles;

WHEREAS, to provide immediate relief and assistance to the victims of this calamity, it is imperative for this Body to declare the municipality under a **State of Calamity** to set aside appropriations for relief, rehabilitation, reconstruction and other services in connection thereof;

WHEREAS, aside from the authority to utilize the Municipality's Calamity Fund for said purpose, it is also the intention of the Sanggunian that any assistance or benefit from National Government Agencies may be availed of by its qualified constituents to supplement the amount which they may receive from such calamity fund to help augment their needs;

WHEREAS, several government employees in the municipality applied, or attempted to apply, for an emergency loan with the Government Service Insurance System (GSIS) and other agencies, but as per recommendations thereof, there must be a corresponding request from the municipal government to provide or grant emergency loan assistance to affected GSIS members in the locality, which form part of this Resolution declaring the Municipality under a State of Calamity;

NOW, THEREFORE, on motion by Coun. Janius M. Yasay and duly seconded by Coun. Edward V. Tolentino in session assembled, be it;

RESOLVED, AS IT IS HEREBY UNANIMOUSLY RESOLVED by the Members of Sangguniang Bayan to declare the entire Municipality of Moncada under a STATE OF CALAMITY due to the onslaught of heavy floods brought about by the continuous downpour of heavy rains and recent tropical depressions;

RESOLVED FURTHER, to request the Government Service Insurance System (GSIS) and other agencies to provide or grant emergency loans to all members of the Municipality;

RESOLVED FINALLY, that copies of this Resolution be furnished the Honorable Mayor Estelita M. Aquino, all department heads and their equivalents, National Government Agencies, Government Service Insurance System (GSIS), Social Security Institutions, GOCCs, PDRRMC, the 37 barangays of this Municipality, and all others concerned for their information and favorable action;
