#### RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY FOR THE ROLL-OUT OF THE PHILIPPINE NATIONAL ID SYSTEM (PHILSYS)

WHEREAS, the Philippine National ID System ("PhilSys"), by virtue of Republic Act No.11055, aims to promote efficient and simplified means for both public and private transactions by registering all Filipinos and resident aliens into an established national identification system;

WHEREAS, the Philippine Statistics Authority ("PSA") was directed to expedite the implementation of the PhilSys registration ahead of its target date in order to augment and maximize its impact with the ongoing implementation of the government's social protection programs, in view of the COVID-19 pandemic;

WHEREAS, LGUs are enjoined to provide assistance in the implementation of PhilSys registration operations in their respective localities pursuant to DILG Memorandum Circular No. 2020-99 dated July 15, 2020;

WHEREAS, in view thereof, a proposed Memorandum of Agreement (MOA) between the PSA and LGU was submitted to this August Body, requesting for authority to be granted to the Local Chief Executive to enter into said agreement for and on behalf of the Municipal Government of Moncada;
