RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MONCADA WATER DISTRICT FOR THE COLLECTION OF ENVIRONMENTAL FEES APROPOS TO THE SEPTAGE MANAGEMENT PROGRAM IN MONCADA

WHEREAS, Section 16 of the Republic Act 7160, otherwise known as the "Local Government Code of 1991", provides that local government units shall ensure and promote the general welfare, right to a balanced ecology, health and safety of the people;

WHEREAS, the Municipality of Moncada is committed to improve the health conditions of its constituents and the protection of the environment within its area in compliance with Section XVII of the Code on Sanitation in the Philippines (P.D. 856 of 1975) on Sewage Collection and Disposal, Excreta Disposal and Drainage;

WHEREAS, pursuant to the Philippine Clean Water Act of 2004 (R.A. 9275), which adopts as national policy of economic growth in a manner consistent with the protection, preservation, and revival of the quality of our water, mandates Local Government Units to prepare a program on septage management and to share the responsibility in the management and improvement of water quality within their territorial jurisdictions;

WHEREAS, in support of the foregoing State policies, the Sangguniang Bayan of Moncada has enacted several measures aimed at protecting the environment and the health of its constituencies;

WHEREAS, given the immediate need to provide Septage Management Services to the public in compliance with above mentioned laws under the

constraints posed by limited resources, the LGU and MWD have seen it fit to partner with a private service provider;

WHEREAS, the Septage Management Program, enacted through Municipal Ordinance No. 03-2020 also requires that a Memorandum of Agreement should be executed between the LGU and MWD for the latter to serve as the implementing arm of THE PROJECT and, among others, to assist in the collection of the ENVIRONMENTAL FEES (EF) from MWD customers. This provision should be complied with before the Service Contract becomes effective and enforceable;

NOW, THEREFORE, premises considered, and on motion by Coun. Alberto C. Marzan, Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health, Social Services and Environmental Protection, hereby authorizes the Municipal Government of Moncada, through the Honorable Mayor Estelita M. Aquino, to enter into a Memorandum of Agreement with the Moncada Water District for the Collection of Environmental Fees apropos to the Septage Management Program in Moncada;

RESOLVED FURTHER, that copies of this Resolution be furnished all concerned parties for their information and appropriate action;
