RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES - ENVIRONMENTAL MANAGEMENT BUREAU REGION 3 FOR THE ESTABLISHMENT OF THE NATIONAL ECOSAVERS PROGRAM IN PUBLIC SCHOOLS

WHEREAS, the Ecological Solid Waste Management Act (RA 9003) provides the legal framework for promoting the systematic, comprehensive and ecological measures for avoiding the generation of solid waste, reducing wastes and the final stage disposing of waste in order to protect public health and the environment;

WHEREAS, Section 8 of RA 9003 mandates the DENR to provide technical and other capability building assistance and support to LGUs and other stakeholders in the development and implementation of local solid waste management plans and programs;

WHEREAS, the existing public-school system within the LGU is a valuable resource that can be tapped in the implementation of a local ecological solid waste management program;

WHEREAS, the DENR-EMB intends to collaborate with the LGU and public schools for the establishment of the National Ecosavers Program (NEP) that aims to reduce the amount of solid waste generated by households through the collection of recyclable materials by elementary and high school students;

Aquino, to enter into a Memorandum of Agreement with the Department of Environment and Natural Resources – Environmental Management Bureau (DENR-EMB) Region 3 for the establishment of the National Ecosavers Program in public schools;
