#### RESOLUTION AUTHORIZING ACTING MUNICIPAL MAYOR JAIME O. DUQUE TO SIGN CHECKS AND ALL WARRANTS DRAWN FOR THE EXPENDITURES OF THE MUNICIPALITY OF MONCADA EFFECTIVE AUGUST 10, 2018 UNTIL AUGUST 25, 2018

WHEREAS, Honorable Mayor Estelita M. Aquino, Local Chief Executive of Moncada, Tarlac has filed her leave of absence from August 10 to 25, 2018;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991, specifically Section 46, provides that the Vice Mayor shall exercise the powers and perform the duties and functions of the Municipal Mayor in case of temporary vacancy, except for the power to appoint, suspend and dismiss employees;

WHEREAS, the Sangguniang Bayan and the Office of the Vice Mayor are in receipt of an Office Order dated July 27, 2018, designating the Honorable Vice Mayor Jaime O. Duque as Acting Local Chief Executive effective August 10, 2018 until August 25, 2018;

WHEREAS, under Section 444 (b) (vi) of the Local Government Code of 1991, the Local Chief Executive has the authority to sign checks and all warrants drawn from the municipal treasury intended for the operation of the municipality, to which appropriations therefor shall be derived from the GENERAL FUND and TRUST FUND;


