RESOLUTION AFFIRMING EXECUTIVE ORDER NO. 24, SERIES OF 2021 ISSUED BY MAYOR ESTELITA M. AQUINO OTHERWISE KNOWN AS AN ORDER ADOPTING AND IMPLEMENTING THE TERTIARY SCHOLARSHIP ORDINANCE OF MONCADA 2020 FOR THE SCHOOL YEAR 2021-2022

WHEREAS, as provided for in the Philippine Constitution, the State shall advance and support education responsive to the needs of the people and society by establishing a system of scholarship grants, subsidies and other incentives to deserving students in both public and private schools, especially to the underprivileged;

WHEREAS, cognizant of this mandate, the Sangguniang Bayan institutionalized the tertiary scholarship program in the locality through the enactment of one of the landmark legislations in Moncada herein referred to as Municipal Ordinance No. 08, Series of 2020, otherwise known as "The Tertiary Scholarship Ordinance of Moncada 2020;"

WHEREAS, the Honorable Mayor Estelita M. Aquino has established the mechanism for its implementation through Executive Order No. 24, Series of 2021 or "An Order Adopting and Implementing the Tertiary Scholarship Ordinance of Moncada 2020" for the realization of the program in the ensuing academic year;

NOW, THEREFORE, on motion by Coun. Thelmaflor A. Espejo, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Education and Human Resource Development, hereby affirms Executive Order No. 24, Series of 2021 otherwise known as "An Order
