WHEREAS, Republic Act 10121, otherwise known as "Philippine Disaster Risk Reduction Management Act of 2010" empowers Local Government Units to provide mitigating and preventive programs, prepare for and earnestly respond to disaster/calamities/crisis/complex emergencies, and attend to relief and rehabilitation work through a Local Disaster Risk Reduction Management Fund Investment Plan (LDRRMFIP) of the Municipal Disaster Risk Reduction and Management Council (MDRRMC) in the Municipality of Moncada for Calendar Year 2019;

WHEREAS, the Municipal Risk Reduction and Management Council (MDRRMC) comprised of local officials, functionaries, sectoral representatives and other stakeholders formulated Programs Projects and Activities (PPAs) in accordance with the Prevention/Mitigation, Preparedness, Response and Relief/Rehabilitation pillars of Disaster Risk Reduction and Management;


