RESOLUTION AFFIRMING EXECUTIVE ORDER NO. 15, SERIES OF 2018, AN ORDER MANDATING THE ADOPTION OF INCIDENT COMMAND SYSTEM IN THE MUNICIPALITY OF MONCADA

WHEREAS, the Municipality of Moncada has been subjected to and affected by the adverse impacts of recurrent natural disasters brought about by climate change, as well as man-made disasters and emergencies;

WHEREAS, said natural man-made disasters have posed real danger to lives and well-being of the residents of Moncada and their properties;

WHEREAS, Sections 4 and 5 of the 1987 Philippine Constitution articulates that "It is the prime duty of the government to serve and protect the people; and that the maintenance of peace and order, the protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy";

WHEREAS, pursuant to Republic Act 10121 otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010", the MDRRMC is tasked to develop policies and plans, and with the implementation of actions and measures pertaining to all aspects of disaster risk reduction and management, which includes good governance, risk assessment and early warning, knowledge building and awareness raising, reducing underlying risk factors, and preparedness for effective response and early recovery;


NOW, THEREFORE, premises considered and on motion by Coun. Rodolfo A. Espejo, duly seconded;
