### RESOLUTION APPROVING THE TOURISM PLAN OF MONCADA FOR CALENDAR YEAR 2021 AMOUNTING TO EIGHT MILLION NINETY THOUSAND NINE HUNDRED THIRTY THREE PESOS AND 32/100 (PHP 8,090,933.32)

WHEREAS, there is an imperative need to prepare a program of tourism activities for calendar year 2021 to serve as a guide for its effective and successful implementation;


