RESOLUTION ALLOWING BARANGAY SAN PEDRO TO UTILIZE A TWO-HUNDRED (200) SQUARE METER PORTION OF LOCAL GOVERNMENT PROPERTY BY RIGHT OF USUFRUCT PARTICULARLY LOCATED INSIDE THEIR BARANGAY PLAZUELA AS SITE FOR THE CONSTRUCTION OF A HEALTH STATION

WHEREAS, endorsed to the Sangguniang Bayan is a Resolution from Barangay San Pedro, through Honorable Victorino B. Bermudez, Punong Barangay, containing therein a request for allotment of a two-hundred (200) square meter portion of a property of the Municipal Government of Moncada for the construction of a Barangay Health Station under the following Landholding Titles: TD# 09-0029-00138 OCT # 63555 Lot # 1947 and TD # 09-0027-00161 OCT # 37399 Lot # 1937;

WHEREAS, RP-US BALIKATAN intends to provide barangay health stations to deserving and qualified barangays and Barangay San Pedro has been fortunate to be selected as one of the project sites;

WHEREAS, for and in consideration of liberality, the Local Government Unit grants the Usufructuary the right of usufruct and perpetual use of the aforementioned lot containing an area of two hundred (200) square meters for the above cited purpose;

WHEREAS, the proposed construction of a Barangay Health Station therein is beneficial to the townspeople, particularly the subject barangay and its outlying catchment areas;

NOW, THEREFORE, premises considered, and on motion by Coun. Alberto C. Marzan Jr, MD, unanimously seconded;

UNANIMOUSLY APPROVED.




