RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – ENVIRONMENTAL MANAGEMENT BUREAU (DENR-EMB) FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF SOLID WASTE MANAGEMENT EQUIPMENT

WHEREAS, the Honorable Mayor Estelita M. Aquino is endorsing to this August Body a proposed Memorandum of Agreement with the DENR-EMB for the supply, delivery, installation, testing and commissioning of solid waste management equipment, requesting that authority be granted to enter into such MOA;

WHEREAS, the Municipality of Moncada has been chosen by the DENR-EMB as a recipient of biodegradable shredder and a composter in order to improve its compliance with the Republic Act 9003 otherwise known as the Ecological Solid Waste Management Act of 2000;

WHEREAS, the initiative aims to enhance the LGU's capacity to address issues concerning solid waste management in its area of jurisdiction;

WHEREAS, after a careful review and perusal thereof, the SB finds the MOA beneficial in the furtherance of the LGU's programs and advocacies consistent with the RA 9003;

NOW, THEREFORE, on motion by Coun. Alberto C. Marzan, Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Environmental Protection, hereby authorizes the Municipal Government of Moncada, through the Honorable Mayor Estelita M. Aquino, to
