### RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE RED CROSS FOR THE MOBILE BLOOD DONATION ACTIVITIES

WHEREAS, presented for consideration of this Body is a Memorandum of Agreement between the Municipal Government of Moncada, Tarlac and the Philippine Red Cross to ensure adequate and readily available supply of blood to the constituents of the Municipality in times of need and emergencies;

WHEREAS, the PRC operates a network of blood service facilities nationwide, with capabilities to provide manpower and logistics support with the Municipality of Moncada necessary for mobile mass blood donation (MBD) activities as well as issuing blood to members in need dependent on the blood service facility categories;

WHEREAS, under the Memorandum of Agreement, the PRC and the Municipality of Moncada shall have a mutual coordination for the conduct mobile blood donation every year at scheduled dates and places convenient to both parties and maintain a pre-determined stock level of blood at their Blood Service Facilities (BSFs) intended solely for issuance and distribution to members;




