**WHEREAS**, cognizant of said requirement of the law, Mayor Estelita M. Aquino issued Executive Order No. 29, series of 2021 entitled Creation and Designation of Cooperatives Development Officer of the Municipality of Moncada to develop guidelines to ensure the smooth delivery of basic services and facilities through organization, promotion and development of cooperatives and providing stakeholders access thereto;

**WHEREAS**, after a careful review of said EO, the SB finds the same to be of merit;
