RESOLUTION APPROVING THE TWENTY PERCENT (20%) DEVELOPMENT FUND APPROPRIATED FOR VARIOUS DEVELOPMENT PROGRAMS, PROJECTS AND ACTIVITIES OF THE MUNICIPALITY FOR CALENDAR YEAR 2022 AMOUNTING TO FORTY-SEVEN MILLION FOUR HUNDRED TWENTY-FIVE THOUSAND FOUR HUNDRED TWENTY-NINE PESOS AND 40/100 (P 47,425,429.40)

WHEREAS, presented to the Sangguniang Bayan for legislative consideration and approval is the proposed development programs, projects and activities of the Municipality of Moncada for Calendar Year 2022, appropriations of which shall be derived from the Development Fund;
