## MEMORANDUM OF UNDERSTANDING

KNOW ALL MEN BY THESE PRESENTS:

This **Memorandum of Understanding** ("MOU") is made and entered into this \_\_\_\_\_ of \_\_\_\_\_ 2018 by and between:

**Municipality of Moncada**, a local government unit in the province of Tarlac , with current address at Moncada Town Hall, McArthur Highway, Poblacion I, Moncada, Tarlac 2308 herein represented by the Municipal Mayor, **HONORABLE ESTELITA M. AQUINO**, duly authorized by virtue of Municipal Ordinance No. \_\_\_, series of 201\_\_\_, hereinafter referred to as "**FIRST PARTY**"

and

**ENVIROKONSULT EQUIPMENT AND SERVICES, INC.**, a private corporation duly organized and existing under and by virtue of the laws of the Security and Exchange Commission (SEC), with business address at Konsult Haus 9030 Feria St., Pook La Paz, Old Balara, Quezon City represented by its CEO, **ANTHONY V. GEDANG** duly authorized by virtue of Board Resolution No. \_\_\_, series of 2018, hereinafter referred to as "**SECOND PARTY**":

### WITNESSETH:

**WHEREAS**, the **FIRST PARTY** is mandated in accordance with Republic Act No. 9275 ("The Philippine Clean Water Act of 2004") to protect, preserve and revive the quality of the country's fresh, brackish and marine waters as an economic growth policy of the States;

**WHEREAS**, to ensure the compliance of the Government's mandate as mentioned, the **FIRST PARTY** seeks to undertake the implementation of a **Septage Management System** that includes provision for septage collection, treatment and disposal services ("the Project");

**WHEREAS**, the **SECOND PARTY** recognizes the significance of the attainment of the **FIRST PARTY**'s programs on septage management that complies with other government agencies' implementing rules and regulations through the planned construction of a Septage Treatment Facility and incidental requirements as defined by the Project, an undertaking that will service and greatly benefit the residents of the Municipality of MONCADA, TARLAC and nearby municipalities;

**WHEREAS**, the **SECOND PARTY** wishes to formally conduct a due diligence on the **Project** to come up with a **Pre-Feasibility Study** for the purpose of submitting an **Unsolicited Proposal** under a **Joint Venture** arrangement between government and private entities pursuant to 2013 NEDA Joint Venture Guidelines;

**WHEREAS**, the Project fosters sustainable development through health and efficient septic management, employing latest technology so that the treated sludge or wastewater shall comply with the **DENR Class C Standard on effluent** prior to discharge to bodies of water;

**NOW, THEREFORE**, in view of the foregoing premises and the mutual covenants hereinafter set forth, the **FIRST PARTY** and **SECOND PARTY** have agreed as follows:

## **1. PROJECT**

The Project refers to the provision of a **Pre-Feasibility Study** for the purpose of submitting an **Unsolicited Proposal** for a Septage Management Program that includes the provision of a **Septage Treatment Plant** including the supply of vacuum trucks to desludge, transport, treat and eventually, the disposal of sludge to designated area or discharge of treated wastewater or sludge coming from residential and commercial establishments to nearby bodies of water.

## **2. UNDERTAKINGS OF THE PARTIES**

### **FIRST PARTY** shall:

Provide **SECOND PARTY** with data and other documents pertinent to the conduct of technical and financial studies and evaluation, in the concept of exercise of due diligence;

Provide **SECOND PARTY** with access, support and assistance in connection with the immediately preceding paragraph; and

The **FIRST PARTY** reserves the right to accept or reject the said unsolicited proposal.

### **SECOND PARTY** shall:

Undertake at its own expense (and at no cost to the Philippine Government or any of its agencies) the necessary technical, economic and financial studies and evaluation that may be necessary for the **SECOND PARTY** to arrive at the best development proposal for the Project;

Complete the necessary technical and engineering, procurement and construction schedule, and the most competitive financing proposal for the Project, and participate in the bidding and implementation of the Project on the basis of the studies and evaluation above, if it is viable to do so;

That the **SECOND PARTY** shall complete the above-mentioned undertakings within a period of 1 month reckoned from the signing date of this MOU; and

The **SECOND PARTY** shall strictly observe confidentiality and shall not publish, or procure or solicit the publication or any document, statement, or communication that may be provided or furnished by the **FIRST PARTY**, without their prior consent, which consent shall not be reasonably withheld.

### **3. MISCELLANEOUS PROVISIONS**

The **SECOND PARTY** shall hold the **FIRST PARTY** free and harmless from any and all cost, suits and liabilities arising out of or in connection with the preparation, submission and processing of **SECOND PARTY**'s undertakings as well as any act in the implementation of this MOU.

### **4. GOVERNING LAW**

The understanding herein entered into shall be governed and construed in accordance with the laws of the Republic of the Philippines. Any dispute and/or disagreement as to the interpretation and application of any of the provisions herein shall be, resolved by the applicable court of law in the **Municipality of MONCADA Province of TARLAC**, Philippines to the exclusion of any other venue.

### **5. EFFECTIVITY**

This MOU shall take effect immediately.
