RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A CONTRACT OF AGREEMENT WITH THE MONCADA WOMEN'S CREDIT COOPERATIVE FOR THE LEASE TERM AGREEMENT ON A REAL PROPERTY OF THE LOCAL GOVERNMENT

WHEREAS, presented for consideration by this Body is a proposed Contract of Agreement between the Municipal Government of Moncada and the Moncada Women's Credit Cooperative (MWCC) for the lease term agreement on the use of a real property owned by the Local Government Unit;
