RESOLUTION ADOPTING THE MUNICIPAL NUTRITION ACTION PLAN OF THE MUNICIPALITY OF MONCADA FOR CY 2022 AMOUNTING TO SEVEN MILLION SIX HUNDRED FORTY-SIX THOUSAND FOUR HUNDRED PESOS (P 7,646,400.00)

WHEREAS, endorsed for consideration by this Body is the proposed Municipal Nutrition Action Plan of the Municipality of Moncada for 2022 containing therein programs, projects and activities deemed necessary to attain the development thrusts of the health and nutrition sector;

WHEREAS, undernutrition is largely prevalent among young children and women, likewise, overnutrition is also prevalent among adults;

WHEREAS, to effectively address the lingering problem of malnutrition in the country, the Philippine Plan of Action for Nutrition (PPAN) 2017 – 2022 was formulated and approved on February 21, 2017 and comes with a budget for the entire period of six (6) years including its monitoring and implementation;

WHEREAS, the Municipality of Moncada has formulated its Municipal Nutrition Action Plan for 2022 consistent with the goals and objectives of PPAN 2017 – 2022;

NOW, THEREFORE, on motion by Coun. Celeste A. Ayson and unanimously seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations, hereby adopts the Municipal Nutrition Action Plan of the Municipality of Moncada for CY 2022 amounting to seven million six hundred forty-six thousand four hundred pesos (P 7,646,400.00);
