**RESOLUTION EXTENDING SINCEREST GRATITUDE AND
ACKNOWLEDGMENT OF CASH ASSISTANCE AMOUNTING TO FIVE
HUNDRED THOUSAND PESOS (Php 500,000.00) FROM THE CITY
GOVERNMENT OF DAVAO TO THE FLOOD VICTIMS IN THE MUNICIPALITY
OF MONCADA**

WHEREAS, the onslaught of Southwest Monsoon or Habagat exacerbated by Typhoons Inday and Josie had caused distress among the townspeople of Moncada because of extensive damage to crops and other livelihood resources due to massive flooding;

WHEREAS, in response to the adverse effects of recent calamities, the Sangguniang Bayan of Moncada passed a Resolution declaring a State of Calamity in the entire Municipality to set aside appropriations intended to hasten government efforts for disaster response, recovery and rehabilitation;

WHEREAS, the City Government of Davao, through their City Ordinance No. 0499-18 series of 2018, had authorized the City Mayor Sara Z. Duterte to utilize a portion of the thirty percent (30%) Quick Response Fund (QRF) out of the five percent (5%) Disaster Management Fund of the City Government to extend financial assistance to the flood victims of affected localities in Central Luzon;

WHEREAS, the Municipality of Moncada is one of the few privileged localities that was earnestly considered by the City Government of Davao to extend financial assistance in order to augment its resources for recovery and rehabilitation efforts;
