#### RESOLUTION EARNESTLY REQUESTING THE MUNICIPAL ASSESSOR'S OFFICE TO UPDATE THE LIST OF PUBLIC DOMAIN IN THE MUNICIPALITY OF MONCADA AND FURNISH THE SAME TO THE SANGGUNIANG BAYAN

WHEREAS, the Regalian Doctrine provides that the State owns all lands and waters of the public domain;

WHEREAS, Article 420 of the Civil Code of the Philippines states that roads, canals, rivers, torrents, ports and bridges constructed by the State, banks, shores, roadsteads, and others of similar character are properties of public dominion;

WHEREAS, there is an imperative need to update the list of properties of public domain in the municipality due to increasing number of concerns arising from the community that involve disputes over properties of public domain;

NOW, THEREFORE, on motion by Coun. Janius M. Yasay, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Rules, Legal Matters, Justice and Good Governance, hereby earnestly requests the Municipal Assessor's Office to update the list of public domain in the Municipality of Moncada and furnish the same to the Sangguniang Bayan;
