#### RESOLUTION APPROVING THE PROPOSED CONSTRUCTION OF A FULLY AUTOMATIC CLIMATE CONTROLLED SYSTEM (CCS) POULTRY HAVING A CAPACITY OF ONE HUNDRED THOUSAND (100,000) HEADS AT BARANGAY TUBECTUBANG, MONCADA, TARLAC

WHEREAS, Mr. Noel Dante M. Caragay, registered owner of a property in Barangay Tubectubang, this Municipality, in partnership with Belmont and San Miguel Foods Corporation, has submitted his intention to put up a poultry industry with a capacity of 100,000 heads stocking population on his property;

WHEREAS, attached to their application are the necessary requirements, such as, 1) Zoning Certificate, 2) Barangay Tubectubang Resolution endorsing the establishment of poultry business 3) Consecutive public consultations held on February 13 and 18, 2018, and October 17, 2018, respectively 4) Environmental Compliance Certificate from DENR-EMB 5) Social Acceptability and other pertinent documents;

WHEREAS, anent the foregoing premises, the Body interposes no objections to the establishment of the aforesaid business, considering that the location is not within a built-up area and thus falls within the agricultural zone of Brgy. Tubectubang as determined in consonance with the Comprehensive Land Use Plan (CLUP) of the Municipality;

WHEREAS, considering too, the socio-economic benefits for Barangay Tubectubang in particular and the entire Municipality in general, the same is hereby recommended for APPROVAL;
