RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH CENTRAL LUZON CENTER FOR HEALTH DEVELOPMENT FOR THE RELEASE OF FUNDS COVERING THE GRANT OF THE COVID-19 SPECIAL RISK ALLOWANCE AND ACTIVE HAZARD DUTY PAY TO QUALIFIED PUBLIC HEALTH WORKERS

WHEREAS, the DOH Central Luzon Center for Health Development (DOH-CLCHD) recognizes the invaluable role of Public Health Workers at this time of national health emergency due to COVID-19 pandemic;

WHEREAS, pursuant to RA 11494, otherwise known as the Bayanihan to Recover as One Act and Administrative Order Nos. 35 and 36 signed by President Rodrigo R. Duterte, qualified public health workers shall receive Active Hazard Duty Pay and Special Risk Allowance, particularly the medical frontliners directly catering to COVID-19 patients;

WHEREAS, in view of the foregoing premises, the proposed Memorandum of Agreement was submitted to this August Body, requesting that authority be granted the Local Chief Executive to enter into said agreement for and on behalf of the Municipal Government of Moncada;
